The 2022/2023 academic year was full of honors and accomplishments which were bookended by two very prestigious national awards bestowed upon Patrick & Henry Community College.

We began the year by receiving the first Rural Community College Alliance (RCCA) Innovation and Access Award for our partnership with Festo Didactic and the National Coalition of Certification Centers (NC3). This incredible affiliation is underscored by the 2,600 NC3 credentials which have been obtained by our P&HCC students. We concluded the year by winning the Southeastern Workforce Development Award from the Community Colleges of Appalachia for our work in the MHC Startup and Grow programs, a collaboration between P&HCC and the MHC Chamber of Commerce. Combined, these two entrepreneurial development programs have generated 314 graduates, 74 new businesses, \$5 million in new capital investment, and 270 new jobs.

As wonderful as it is for the college to be recognized nationally, we are most proud of the impact we are having locally. To that end, we were thrilled to announce that our academic Pell-eligible enrollment grew by 4% over the previous year while our short-term workforce enrollment grew by 42%. This means that we are training and educating more students who are able to obtain the knowledge, skills, and competencies they need to obtain good-paying jobs in the communities served by P&HCC.

Because of this, we remain so very grateful for the continued support of our donors. Simply put, we could not fulfill our mission of economic mobility without these resources. Every penny given enables us to provide students what they need in order for them and their families to experience financial stability.

The economic renaissance is very real in our community and P&HCC is delighted to be our community's education and training provider helping to ensure a very bright future for our service region.

As always, it is the honor of my lifetime to serve as the president of Patrick & Henry Community College.

## Carter Bank & Trust Donates \$48,000 to P&HCC's Workforce, Economic and Community Development Division

Carter Bank & Trust recently donated \$48,000 in grant money to Patrick & Henry Community College Foundation (P&HCC) to put toward the school's Workforce, Economic and Community Development division.

Through its Community Reinvestment Act and Community Development programs, the bank is reinvesting a jobs retention grant reward back into the community for workforce development, a press release states.

"Being a partner to the communities where we're privileged to serve has been a hallmark of Carter Bank & Trust for nearly 50 years," Carter Bank & Trust Executive Vice President and Director of Regulatory Risk Management Loran Adams said in the release. "Having our headquarters in Martinsville and Henry County, it's important to us to help give residents opportunity. By partnering with and supporting Patrick & Henry Community College we're able to help people get critical skills to fill job openings in our area."

P&HCC's Workforce, Economic and Community Development division works closely with the Martinsville and Henry County Economic Development Corporation to identify the labor needs of industries moving to the area and helps prepare workers to meet those needs.

P&HCC Vice President of Workforce, Economic, Community Development Rhonda Hodges said in the release the \$48,000 donation benefits not only the school, but the community and, most importantly, the students.

"We're about improving the economic mobility of our students and the economic development of our community," Hodges said. "So, it's a tremendous impact for us. Providing flexible funding allows us to buy equipment for programs and provide supportive services to students. Our students are often working students and as I like to say, 'they have life and life happens,' so often they need supportive services like transportation or child care so \$48,000 goes further than anyone can imagine when it comes to helping us and helping our students."

Programs in PHCC's Workforce, Economic and Community Development Division include: College Career Center, StartUp MHC, Idea Center, Fabrication Lab, Precision Center, Small Scale Manufacturing, certification programs for Nurse Aid, Electrical, Commercial Driver's License (CDL), Construction, HVAC, Electrical, and Carpentry certification programs, and academic programs including welding, machining, mechatronics, and Racing College of Virginia.

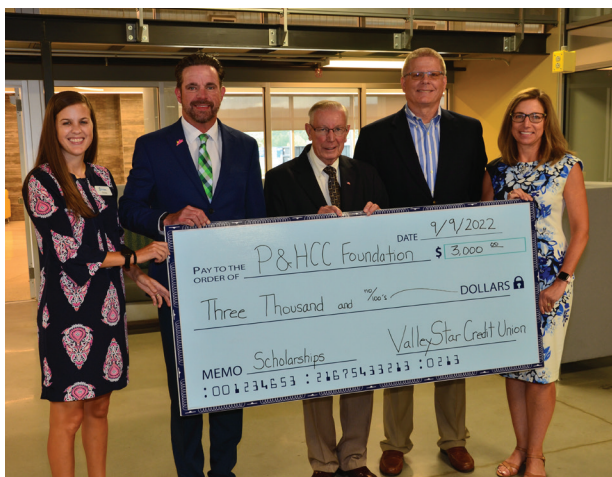


## P&H Scholar named Virginia Banking Fellow

# Sentara Healthcare Awards Grant to P&HCC Students

In partnership with Sentara Healthcare's Sentara Cares program, Virginia Foundation for Community College Education (VFCCE) has awarded Patrick & Henry Community College Foundation \$8,850 to provide emergency assistance grants to healthcare students to overcome financial hardships and excel in college. Students must be enrolled in a healthcare or healthcare-related undergraduate or professional degree or certificate or credential program and have demonstrated financial need as determined by the Office of Financial Aid.

"In addition to the usual college tuition and fees, most healthcare programs require additional expenses for uniforms, physical examinations and required immunizations, drug screens, criminal background checks, and specific textbooks and resources. Fees for these items can be very costly," shared Amy Webster, P&HCC Director of Nursing and Allied Health.

Sentara Cares funding will support program placed students in the associate's degree nursing program, practical nursing program, Paramedic and EMS related pathways, physical therapist assisting, and workforce medical certification training at P&HCC.

"We are pleased to be able to direct these funds to support scholarships and the expensive textbook requirements for healthcare students. Healthcare has one of the most expensive textbook requirements of any program we have and these funds will help ensure that students are able to continue their work to fill critical positions in our community," said P&HCC Foundation Executive Director Tiffani Underwood.

### Community College Philanthropists Honored with 2023 Chancellor's Award for Leadership in Philanthropy

ValleyStar Credit Union of Martinsville has received the 17th Annual Chancellor's Award for Leadership in Philanthropy. ValleyStar was nominated for the award by Patrick & Henry Community College.

More than two dozen individuals, families, and organizations have earned the 2023 Chancellor's Award for Leadership in Philanthropy. The awards were presented at a luncheon ceremony in Richmond on Tuesday, April 18. New VCCS Chancellor Dr. David Doré was the keynote speaker.

"It is a privilege and an honor to be in the company of such an esteemed group of philanthropists," Doré said. "Were it not for your generosity, some of our students would have to put their hopes and dreams on hold, while others might have to abandon them altogether. Thanks to you, however, our students will be able to work in an environment that is relatively free of the kind of financial pressures that can paralyze or even derail their forward progress, and for that, we are extremely grateful."

The annual event, hosted by the Virginia Foundation for Community College Education (VFCCE), honors leading philanthropists from each of Virginia's 23 community colleges as well as the statewide foundation. Recipients are nominated for their outstanding commitment to the growth and development of Virginia's community colleges and their respective foundations. This year's class of distinguished philanthropy leaders has collectively contributed \$14 million dollars to Virginia's Community Colleges.

Regarding ValleyStar's support of P&HCC, Dr. Greg Hodges said, "The association between ValleyStar and P&HCC began in 1992. Since that time, they have

provided more than \$100,000 in gifts to support academic and workforce students, the annual operational expenses of the Motorsports program, and our COVID 19 Student Emergency Fund. Additionally, they regularly answer the call to serve as a corporate sponsor for a multitude of college events."

For more than 30 years, ValleyStar Credit Union has partnered with Patrick & Henry Community College Foundation to support students, programs and events at Patrick & Henry Community College. What started in 1992 with a single donation in support of the scholarship program, grew into a true corporate partnership including donations, sponsorships and ValleyStar senior leadership also serves on the P&HCC Foundation Board.

In 2001, they established the ValleyStar Credit Union Annual Scholarship Fund to support students studying business and finance. Since its inception, more than 30 students have benefited from this scholarship. Additionally, In 2015, ValleyStar began supporting the Motorsports program at P&HCC, which allows the program to race their late-model car in local races at Martinsville Speedway while continuing to provide hands-on training opportunities for students. And in 2020, when the COVID-19 Pandemic struck, ValleyStar was one of the first corporate entities to step up and support the COVID-19 Emergency Relief Fund for P&HCC students.

"ValleyStar Credit Union has shown time and time again just how committed they are to supporting the students, programs and events at Patrick & Henry Community College," said P&HCC Foundation executive director Tiffani Underwood.

## INAUGURATION OF DR. HODGES

### Dr. Greg Hodges sworn in as president of Patrick & Henry Community College

At P&HCC, Hodges has held a wide variety of positions such as: vice president of academic and student success services; vice president of institutional advancement, effectiveness, and campus life; executive director of the P&HCC Foundation; dean of academic success and college transfer; dean of developmental education and transitional programs; assistant dean of arts, science, and business technology; coordinator of P&HCC's quality enhancement plan for SACSCOC reaccreditation; and adjunct professor and full time professor of early childhood education.

"As an academic leader who is passionate about the transformative power of higher education he has stepped into this new role ready to lead this institution and create opportunities to develop ideas, innovations that drive our economy and our society forward," Agnew said.
