



The 2023/2024 academic year was once again full of honors, awards, and accomplishments for Patrick & Henry Community College.

P&HCC was deeply honored to be recognized as the Entrepreneurial College of the Year by the National Association of Community College Entrepreneurship (NACCE). Awarded because of our partnership with the StartUp and Grow programs, which are delivered in conjunction with the Martinsville & Henry County Chamber of Commerce, these two training tracks have become an essential part of our region's entrepreneurial ecosystem. Similarly, P&HCC was thrilled to be named a Leader College of Distinction by Achieving the Dream. As one of only six colleges in the country recognized last year, this award highlights our college's commitment to the economic mobility of our students and their families.

We were also thrilled to be recognized as one of the best colleges in the nation to work for, according to the Great Colleges to Work For® program. Patrick & Henry Community College won honors in six categories this year: Job Satisfaction & Support, Professional Development, Compensation & Benefits, Mission & Pride, Faculty Experience, and Confidence in Senior Leadership. Patrick & Henry Community College was also named to the Great Colleges Honor Roll, a status granted to only 42 colleges who are highlighted most across the recognition categories each year.

As wonderful as it is for the college to be recognized nationally, we continue to be extremely proud of the impact we are having locally. To that end, we were thrilled to announce that our academic Pelleligible enrollment grew by 1% over the previous year while our short-term workforce enrollment grew by 53%. For the academic year, 462 unduplicated graduates earned 633 academic credentials (degrees, certificates, and career studies certificates) while 339 additional students earned Fast Forward work-force certifications. Altogether, 801 students earned 972 credentials/certifications for 2023/2024.

We remain so very grateful for the continued support of our donors. Simply put, we could not fulfill our mission of economic mobility without these resources. Every penny enables us to provide students what they need in order for them and their families to experience financial stability. The economic renaissance is very real in our community, and P&HCC is delighted to be our community's education and training provider helping to ensure a very bright future for our service region.

As always, it is the honor of my lifetime to serve as the president of Patrick & Henry Community College.

P&HCC to Expand Healthcare Training with TRRC Grant

Patrick & Henry Community College was awarded \$149,140 from the Tobacco Region Revitalization Commission to expand healthcare training capacity in Nurse Aide, Clinical Medical Assistant, Medication Aide, and Phlebotomy Technician programs. These programs lead to short-term credentials that quickly allow students to enter high-demand health careers in the region.

"We are grateful for the continued support of the Tobacco Region Revitalization Commission. Their partnership and support of P&HCC ensures our students have access to programs and training that lead to high demand careers in our area," said P&HCC Foundation executive director Tiffani Underwood.

The expansion of programming both on P&HCC's main campus and in partnership with programming at The Franklin Center in Rocky Mount will increase credentials and help place medical professionals in jobs in the area.

"Career opportunities in the healthcare industry are abundant and pay well, providing economic mobility for our graduates and their families. Patrick & Henry Community College has a strong history of preparing students for these careers, and we are excited to partner with Franklin County and the Tobacco Region Revitalization Commission to offer healthcare certification programs at The Franklin Center. Once a faculty member is hired, P&HCC plans to offer healthcare programming that meets both the interests of students and needs of employers," said P&HCC vice president for workforce, economic and community development Rhonda Hodges.

P&HCC Foundation will provide a dollar for dollar match to supplement TRRC funding.

P&HCC's Patriot Pantry Receives Community Support

P&HCC has hosted Patriot Pantry, a food and hygiene shop for students, since 2016. The Pantry exists thanks to the donations of P&HCC staff and community members. Bassett Kiwanis Club was one such recent donor, gifting the Pantry funds to purchase items for the spring semester.

Spencer's memoir centers on four generations of his family, revealing their colorful past. The open and easy-toread book is a life story which many people will relate to as some situational descriptions were likely a part of their own upbringing in the same marginalized community. The themes of self-reliance, self-determination and hard work are scattered throughout to capture, retain and inform the reader of growth tracks and steps to take to achieve their goals.

"As the son of a coal miner and a domestic worker, I am grateful for all their parenting decisions while working with limited resources. I am appreciative that we don't have to dwell on the past; however, the instructions from that time are still especially relevant today," said Spencer.

"From the 'force-multipliers', the instructors, administrators and support staff at P&HCC who intentionally guided us through

to matriculation, we learned the importance of paying it forward. Other important lessons we learned were to be consistent, bring good energy, manage stress and provide encouragement for others; just as my dedicated instructors had done for us. Most importantly, we learned that education is the gift that keeps on giving so rarely did any of us ever miss a day of classes. Dr. Greg Hodges and staff are indeed accountable to make sure the door stays open so others can enter behind us to make their own 'Razz-Ma-Tazz' with the same high-quality education in a richly diverse environment," Spencer added.

P&HCC to Pilot Childcare Apprenticeship Program

Patrick & Henry Community College (P&HCC) has been awarded \$31,000 from an anonymous donor to support piloting a model for Early Childhood Education apprenticeships with local childcare providers. The grant will supplement employer salaries to reach a \$15/hr salary for all apprenticeships. With this generous funding, P&HCC will build a comprehensive career model that benefits students as well as youth, employees, and employers, all while Early Childhood Development students are also earning their associate's degree.

In the pilot program, 8 students will commit to a 5 month apprenticeship of 340 working hours while also completing their associate's degree in Early Childhood Development. P&HCC plans to use this model to create a federally registered apprenticeship program for Early Childhood Development students, who would all commit to working 2,000 hours over two years with local childcare providers, coinciding with the length of time needed to complete the Early Childhood Development program.

P&HCC's long-term vision is that the program will grow in future years to include more cohorts of P&HCC students participating in the apprenticeship model, with the potential to expand to other colleges. If successful, P&HCC's Early Childhood Apprenticeship Program could be replicated throughout the state to address early childhood center staff shortages. This model will provide a valuable, hands-on learning experience for students while supporting economic development through addressing the childcare needs of regional employers whose employees depend on reliable, quality childcare.

"We believe that opportunities should be available to employees to upskill and earn family-sustaining annual salaries in order to retain and sustain top-tier educational opportunities for the children in our community," said P&HCC president Dr. Greg Hodges, adding, "We are so grateful to the donors who are supporting our pilot program so that we can work to make this a reality for our region's childcare facilities."

Patrick & Henry Community College (P&HCC) offers an Early Childhood Education Certificate and the Early Childhood Development Associate of Applied Science degree. The certificate program is a 31-credit program designed to improve the quality of education provided in early childhood programs. The Early Childhood Development Associate's Degree program is designed to prepare early childhood professionals with the knowledge and skills needed to successfully manage a classroom and teach students from diverse backgrounds with varied academic and developmental needs. Graduates are prepared to work with students in a variety of educational environments including childcare centers, family day homes, Head Start, and public or private schools.





MET II Grand Opening

Patrick & Henry Community College held the Grand Opening of our Manufacturing, Engineering, and Technology Building II (MET II) on November 30, 2023. This 22,000 square feet facility triples our welding capacity and expands virtual and robotic welding. The annual memorial motorcycle ride is both a way for fellow veterans and servicemen to remember fallen Marine Jonathan Williams Bowling and a chance for these men and women to continue his legacy of giving back to the community.

"This will be our final ride and we want to thank everyone who has supported us and helped us realize our goal of Jonathan's scholarship becoming perpetual," said ride organizer Darrell Bowling.

The event began at 10 a.m. at Patrick County High School (215 Cougar Lane) in Stuart, Virginia and featured live music, food, and door prizes. The ride began at noon. Registration was \$15 per vehicle, and each entrant had a chance to win prizes. Trophies were given for the bike traveling the farthest to participate in the ride. All proceeds from the ride went towards the Corporal Jonathan W. Bowling Memorial Scholarship, which was established to honor his legacy and provide a Patrick County student with funding to attend Patrick & Henry Community College (P&HCC). The ride has collected a total of \$89,000.00 in donations to date.

In 2023, Carter reinvested a \$48,000 jobs retention grant award back into the community by donating it to the Patrick & Henry Community College Foundation to support workforce development efforts furthering their longstanding commitment to Patrick & Henry Community College and to the region.

While both are important, it is the latter that creates transformational opportunities for change and improves the quality of life of a local citizenry. P&HCC Receives Gene Haas Foundation Grant

Scholarships will be awarded to students who are currently enrolled or will be enrolling in a CNC Technology training or CNC machining-based engineering program and to support student participation in SkillsUSA's CNC competitions.

P&HCC offers multiple training programs that teach CNC machine technology and/or engineering. P&HCC's programs are designed to prepare graduates for immediate employment within advanced manufacturing including careers in motorsports, engineering technologies, advanced technology and industrial positions, and other manufacturing related positions. P&HCC is proud to prepare students for work in a high-demand, high wage field to meet the growing needs of employer partners.

"The Gene Haas Grant gives students an opportunity to excel in the Precision Machine Program by providing scholarships to students to assist them in completing our programs ultimately earning them Career Studies Certificates in Machining Technician (manual machining) and CNC Operator/Programmer. These skill sets are vital to support our region in the national mission to bring manufacturing back to the US from overseas. These manufacturing jobs are in high demand, pay well, and are constantly evolving to meet the needs of local and regional manufacturers. I am very thankful to the Gene Haas Foundation for supporting our students here at P&HCC," said Precision Machining instructor Justin Durden.

GHF's primary goal is to build skills in the machining industry by providing scholarships for CNC machine technology students also to provide students with the experience of collaboration with a team by competing in a competition that highlights design, engineering and manufacturing with CNC machined parts as a primary component.

Motorsports instructor Talmage Thomas said, "Gene Haas Foundation provides financial assistance for students so that they can apply to repair cars and have gas money for transportation. The grant's support for buying basic tools needed to pursue careers in motorsports manufacturing is critical for our students."
